**WHEREAS**, plats of Paradise Point Access Road, Paradise Point Sector Two, and Paradise Point Sector One A were recorded in the Probate Office of Shelby County, all being recorded over twenty years ago, and

**WHEREAS**, the recording of the plats established and vested these roads as public roads, however, they were not accepted into the County’s inventory of public roads for maintenance because numerous deficiencies were never corrected by the developer or contractor, and

**WHEREAS**, the road has been in use by the general public for a period of time exceeding twenty years, and in the opinion of the County Attorney, the road has been accepted by the public on behalf of the County , and

**WHEREAS**, with such acceptance by the public, the County now has the duty to maintain the road, consistent with the nature, quality, and extent of public use.

**THEREFORE, BE IT RESOLVED** the County hereby accepts the road created by the aforementioned plats into the County’s inventory of public roads for public maintenance. However, nothing contained herein shall obligate the County to provide repair, upgrades, or enhancement to the road that would have been the developer’s responsibility, and the County’s maintenance responsibility will be limited to that which is consistent with the nature, quality, and extent of public use.


